



## Experience Camps Travel Scholarship Application

### PURPOSE

The ATSS Foundation will provide financial support for travel to Experience Camps for children who have lost a parent, sibling or caregiver to a roadway work zone construction or maintenance activity within the work zone, including mobile operations and the installation or roadside safety features. The camps are free to attend and the travel scholarship will cover 100% of the travel expenses for the eligible child and for the guardian to escort their child to the camp. This means all costs are covered for a child to attend camp.

### EXPERIENCE CAMPS FOR GRIEVING CHILDREN

Experience Camps is a national network of one-week, overnight summer camps and year-round programs for children and teens (grades 4–12) who have experienced the death of a parent, sibling or primary caregiver. Since 2009, the camps have transformed the lives of thousands of children by reframing the experience of grief and empowering them with the confidence, skills and support to move forward with their lives.
