

## **FIREARMS TRANSFER FROM FFL TO FFL**

Sporting Clays Event participants have the option to ship their shotgun beforehand from their local Federal Firearms Licensee (FFL) directly to Right To Bear, an FFL based in Alpine, CA.

Right To Bear will receive from outside dealer, unbox and inspect firearm condition after travel, book into their firearms systems as a temporary hold, deliver the firearms to the respective shooter at the event (ID required), recollect the firearm after the event, box it securely, and shipping back to the shops the firearm arrived from.

The participant is responsible for all shipping fees and transfer fees to ship their firearm.

### **Procedures for Incoming Transfers**

If you are shipping a shotgun to Right To Bear ahead of the event, you must:

- A. Complete this form and submit it to [foundation@atssa.com](mailto:foundation@atssa.com) to notify us that you plan to ship your shotgun ahead of time and would like Right To Bear to hold your firearm. The form should include your full legal name, address, telephone number, email address, and the name of the FFL shipping the firearm to Right To Bear along with their name, contact information, and the make and model of the firearm.
- B. A copy of your driver's license.
- C. Provide your local FFL shipping the firearm to Right To Bear a copy of our Federal Firearms License (FFL) (provided after we receive your form). It is your responsibility to provide Right To Bear all information necessary to your local FFL.
- D. Ensure that the person shipping the firearm includes a copy of their FFL with the shipment. In addition, they should include your name and contact information with the firearm.
- E. Right To Bear will notify you that the firearm has arrived.
- F. You are responsible for working with Right To Bear to ship your firearm back to your local FFL.
